1	WHEREAS,	pursuant to Legislative Council Resolution No. 98-472, the Nation entered into
2		an Attorney Contract with the law firm of Fines & Oden (the "Attorneys") for the
3		purpose of continuing legal representation of the Nation in connection with
4		litigation in Federal District Court related to the operational and financial
5		affairs of the Tohono O'odham Farming Authority ("TOFA"); and
6	WHEREAS,	the Attorney Contract was in the amount of \$60,000 and payable from the
7		operating budget of the Office of Attorney General for fiscal year 1999; and
8	WHEREAS,	pursuant to Resolution No. 99-057, the Legislative Council approved
9		Amendment No. 1 to the Attorney Contract increasing the Contract amount by
10		\$75,000, payable from Account No. 01-1019-810 which is maintained to support
11		the Meadowood lawsuit and the TOFA litigation; and
12	WHEREAS,	additional funding for the Contract in the amount of \$55,000, payable from
13		such Account, has been recommended by the Attorney to ensure
14		uninterrupted representation in the pending lawsuit in Federal District
15		Court; and
16	WHEREAS,	the Domestic Affairs Committee recommends approval of Amendment No. 2
17		to the Attorney Contract.
18	NOW, THER	REFORE, BE IT RESOLVED THAT:
19		1. The Tohono O'odham Legislative Council approves Amendment No. 2 to
20		the Attorney Contract with the law firm of Fines & Oden, in the form
21		attached hereto, which increases the Contract amount to \$190,000 for
22		fiscal year 1999.
23		2. The Legislative Council authorizes expenditure of the \$55,000 increase in
24		the Attorney Contract from Account No. 01-1019-810.
25		3. The Legislative Council authorizes and directs the Chairman of the Nation
26		to execute Amendment No. 2 to the Attorney Contract.
