## **RESOLUTION NO. <u>99-450</u>**

1	WHEREAS, the Tohono O'odham Nation desires to provide medically necessary
2	transportation services to members regardless of ability to pay; and
3	WHEREAS, the Tohono O'odham Nation desires to collect any and all third party
4	reimbursements to provide medically necessary transportation; and
5	WHEREAS, a health transportation services budget in the amount of \$1,325,100.00 is
6	submitted for the purchase of vehicles to implement medically necessary
7	transportation services.
8	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:
9	1. It hereby approves the vehicle budget as submitted.
10	2. The budget duration will be for August 01, 1999 to September 30, 1999.
11	3. Funds will be appropriated from the remaining balance of the FY 1998
12	savings, in the amount of \$114,300.76, with the balance of \$1,210,799.24 to
13	be appropriated from the IC 007 Account.
14	4. The remaining balance of the IC 007 Account will be reserved to cover
15	anticipated operational costs for the Health Transportation Services
16	budget.
17	5. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice
18	Chairman and any designated Official is hereby authorized to negotiate
19	and execute contracts associated with this fund.
