

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Legislative Branch FY 1999 Budget Amendment No. 2)**

**RESOLUTION NO. 99-453**

1 **WHEREAS, the Legislative Branch FY 1999 Budget was approved by Resolution No. 98-397,**  
2 **which provides for an Attorney Position within the Legislative Branch; and**  
3 **WHEREAS, the Legislative Council has recommended that funds would be better utilized**  
4 **by the existing attorney contract for legal services provided to the branch by**  
5 **the law firm of Korn, Waterman & Simon, payable from Account No. 01-1002-**  
6 **810 - Professional Services; and**  
7 **WHEREAS, the Legislative Council hereby amends the Legislative Branch FY 1999 budget,**  
8 **deleting the Attorney Position and transferring remaining funds to Line Item**  
9 **810-Professional Services.**  
10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**  
11 **hereby approves the FY 1999 Legislative Branch Budget Amendment No. 2,**  
12 **deleting the Attorney Position and transferring remaining funds to Line Item**  
13 **810-Professional Services.**

14 **The foregoing Resolution was passed by the Tohono O'odham Council on the 06<sup>TH</sup> day of**  
15 **AUGUST, 1999 at a meeting at which a quorum was present with a vote of 1,576.7 FOR; 191.3**  
16 **AGAINST; 397.5 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council**  
17 **by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**  
18 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**  
19 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**  
20 **of the Act of June 18, 1934 (48 Stat. 984).**


