RESOLUTION NO. 99-460

1 **WHEREAS, the U.S. Environmental Protection Agency (USEPA) awarded \$200,000.00**
2 **cooperative agreement funds to the Tohono O'odham Nation for the**
3 **Brownfields Initiative Redevelopment Project; and**

4 **WHEREAS, the Brownfields Redevelopment Project will assess the Minerec Mining**
5 **Chemical Company, located in San Xavier District; and**

6 **WHEREAS, the assessment work will be contracted and performed by an environmental**
7 **consultant; and**

8 **WHEREAS, advertisement within newspapers will be needed to hire a qualified**
9 **environmental consultant group to assist the Nation in their efforts to protect**
10 **and maintain the environment for the well being of the Nation's members.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
12 **Approves the #1 Budget Modification to the Brownfields Economic**
13 **Redevelopment Initiative Grant.**

14 **The foregoing Resolution was passed by the Tohono O'odham Council on the 16th day of**
15 **AUGUST, 1999 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
16 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council**
17 **by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
18 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
19 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**
20 **of the Act of June 18, 1934 (48 Stat. 984).**
