

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving The Submission of The FY 1999 Office of Justice Programs (OJP) Designated
Tribes Correctional Facilities on Tribal Lands Grant Application)**

RESOLUTION NO. 99-463

1 **WHEREAS, the Tohono O'odham Nation is a BIA designated tribe for purposes of the OJP**
2 **Designated Tribes Correctional Facilities on Tribal Lands grant; and**

3 **WHEREAS, the Gu Achi District has been informed of this grant opportunity and provides**
4 **to the Legislative Council its authorization, support and land set aside for the**
5 **proposed corrections facility within the Gu Achi District; and**

6 **WHEREAS, the Nation must provide proof of authority to apply as well as a commitment**
7 **to support, maintain and operate the finished facility upon completion as a**
8 **threshold requirement; and**

9 **WHEREAS, the proposal being submitted by the Nation is for the first phase of project**
10 **development including feasibility study, planning and design only.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
12 **authorizes the proposal for the Gu Achi Adult and Juvenile Corrections Facility**
13 **grant to go forward with all the support and commitment from the Nation as**
14 **required by the granting agency.**

15 **The foregoing Resolution was passed by the Tohono O'odham Council on the 16TH day of**
16 **AUGUST, 1999 at a meeting at which a quorum was present with a vote of 1,955.9 FOR; -0-**
17 **AGAINST; -0- NOT VOTING; and 209.6 [04] ABSENT, pursuant to the powers vested in the**
18 **Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,**
19 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
20 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
21 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


