

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval for Gu-Vo District Carry-Over of FY 97/98 Budget to Consolidate with the
Districts FY 98/99 Budget)**

RESOLUTION NO. 99-466

1 **WHEREAS, the Gu-Vo District Chairman and Accounting Clerk have been meeting with**
2 **the Tohono O'odham Accounting Department to compare the balance of FY**
3 **97/98 Budget; and**

4 **WHEREAS, the total amount of the balance, which both parties agree is One Hundred**
5 **Twenty-Seven Thousand Three Hundred Eleven 29/100 Dollars (\$127,311.29);**
6 **and**

7 **WHEREAS, the balance of \$127,311.29 will be divided among the four communities and**
8 **the District Administration; and**

9 **WHEREAS, the extra funds will alleviate the financial burden in the communities and**
10 **District Administration.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council in the**
12 **best interest of the Gu-Vo District Administration and it's four (4)**
13 **communities approve for them to utilize the left over funds from FY 97/98**
14 **Budget.**

15 **BE IT FURTHER RESOLVED that the communities and the District Administration will**
16 **divide the FY 97/98 carry-over funds as follows:**

District Administration	\$25,078.21
Gu-Vo Community	\$25,558.27
Ali Chugk Community	\$25,558.27
Pia Oik Community	\$25,558.27
Kukatch Community	\$25,558.27

26 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
27 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
28 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


