

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving and Confirming amendment to Legislative Council Resolution  
No. 99-398)**

**RESOLUTION NO. 99-470**

1   **WHEREAS, by Resolution No. 99-398, the Tohono O'odham Legislative Council approved**  
2                   **the Miss Tohono O'odham Nation Committee's Supplemental Request for FY**  
3                   **1999; and**

4   **WHEREAS, the Supplemental Request was in the amount of \$28,011.47 for fiscal year 1999;**  
5                   **and**

6   **WHEREAS, the Supplemental Request for FY 99 was modified to be adjusted to reflect**  
7                   **funding needed for the remaining three months; and**

8   **WHEREAS, it was not clear if the line items were to be recurring line items and if they**  
9                   **were to be added and allocated for the FY 2000 base budget of the Miss Tohono**  
10                  **O'odham Nation Committee's operating budget; and**

11   **WHEREAS, the Human Resources Development Committee (HRDC) is the Oversight**  
12                  **Committee of the Miss Tohono O'odham Nation Committee; and**

13   **WHEREAS, the HRDC Committee recommends approval and confirmation that funding**  
14                  **be allocated and added to the Miss Tohono O'odham Nation's FY 2000**  
15                  **operating base budget.**

16   **NOW, THEREFORE, BE IT RESOLVED THAT:**

17                   **1. The Tohono O'odham Legislative Council hereby approves and**  
18                   **recommends that line items identified as recurring line items in the**  
19                   **Committee's Supplemental Budget request for FY '99 as approved by**  
20                   **Legislative Council Resolution No. 99-398, be allocated and added to the**  
21                   **fiscal year 2000 operating budget for the Miss Tohono O'odham Nation**  
22                   **Committee.**

23                   **2. The line items identified as recurring items in the Miss Tohono O'odham**  
24                   **Supplemental Budget as approved by Resolution No. 99-398 be adjusted**  
25                   **to reflect the amount needed for FY 2000 at twelve months.**

6 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**  
7 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


