12	hereby approve the Department of Labor, Title IVA FY 1999 Budget Modification
13	in the amount of \$592,701.00.
14	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono
15	O'odham Nation's Officials, to wit: the Chairman and any designated official are
16	hereby authorized to negotiate and execute the contract, provided however,
17	that any amendment affecting the funding or funding levels of this contract
18	shall be submitted for further prior approval by this Council.
