

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1999 Year 02 Special Diabetes Data Improvement Grant Budget
Modification #1 and Revised Scope of Work)**

RESOLUTION NO. 99-489

- 1 **WHEREAS, the Tohono O'odham Department of Human Services was approved for a grant**
2 **to establish the Data Improvement Program under the Special Diabetes**
3 **Program for Indians, authorized by the Balanced Budget Act of 1997; and**
- 4 **WHEREAS, funds were set aside from the Special Diabetes Program for Tohono O'odham**
5 **Nation; and**
- 6 **WHEREAS, the Tohono O'odham Legislative Council through Resolution #98-150**
7 **established and approved the FY 1998 budget for the Data Improvement Grant**
8 **and;**
- 9 **WHEREAS, due to delay in program implementation, distribution of the FY 1998 Data**
10 **Improvement funds of \$116,154.00 were not utilized; and**
- 11 **WHEREAS, the amount of \$116,154.00 includes the Pascua Yaqui Tribe allowance at 17.88%**
12 **in the amount of \$20,768.00 and Tohono O'odham Nation at 82.12% in the**
13 **amount of \$95,386.00; and**
- 14 **WHEREAS, the Tohono O'odham Nation and the Pascua Yaqui Tribe have determined**
15 **different needs and will separate and develop our own data improvement goals**
16 **and objectives; and**
- 17 **WHEREAS, the Nation is requesting to modify the FY 1998 (Year 01) budget amount of**
18 **\$116,154.00 to separate funds in the amount of \$20,768.00 from the Data**
19 **Improvement Grant to be returned to the Indian Health Service Area Office for**
20 **redistribution of funds to the Pascua Yaqui Tribe.**
- 21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
22 **approves the FY 1998 Year (01) Data Improvement Grant in the amount of**
23 **\$95,386.00 to be carried over into the FY 1999 Year (02) allocation of \$95,386.00**
24 **with a total FY 1999 Budget amount of \$190,772.00 which covers the period**
25 **starting June 01, 1999 to May 31, 2000.**

1 **BE IT FURTHER RESOLVED** that the Tohono O'odham Nation officials, to wit: the Chairman
2 and Vice Chairman or designated officials are hereby authorized to negotiate
3 and execute the contract and expend funds when received.

4 **The foregoing Resolution was passed by the Tohono O'odham Council on the 15TH day of**
5 **SEPTEMBER, 1999 at a meeting at which a quorum was present with a vote of 1,993.7 FOR; -0-**
6 **AGAINST; 171.8 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council**
7 **by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
8 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
9 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
10 **the Act of June 18, 1934 (48 Stat. 984).**
