

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Tohono O'odham Department of Human Services - Division of
Psychological Services - FY 2000 SMI Day Program Tribal Demonstration
Project Budget (11-1429))**

RESOLUTION NO. 99-501

1 **WHEREAS, the Tohono O'odham Nation is currently operating the Tohono O'odham**
2 **Psychological Services Treatment Program for the Seriously Mentally Ill Tas**
3 **Tonlik Ki Day Program through a P.L. 93-638 I.H.S. grant; and**

4 **WHEREAS, the I.H.S. grant ends August 31, 1999; and FY 2000 funding will not take effect**
5 **until October 01, 1999; and**

6 **WHEREAS, the program has prepared the FY 2000 Tas Tonlik Ki Day Program using I.H.S.**
7 **grant carryover monies to cover GSA vehicles for the months of September -**
8 **December 1999 in the amount of \$16,393.69.**

9 **NOW, THEREFORE, BE IT RESOLVED:**

- 10 **1. That the Tohono O'odham Legislative Council hereby approves the FY 2000**
11 **Tas Tonlik Ki Day Program (SMI Day Program Tribal Demonstration Project)**
12 **Budget (11-1429) at \$16,393.69 to cover GSA vehicles for four months from**
13 **September 01 to December 31, 1999, effective September 01, 1999.**
- 14 **2. That the Tohono O'odham Nation's Officials, to wit: the Chairman, Vice**
15 **Chairman and any designated Officer are hereby authorized to negotiate**
16 **and execute the proposal.**

17 **The foregoing Resolution was passed by the Tohono O'odham Council on the 16TH day of**
18 **SEPTEMBER, 1999 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
19 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
20 **Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
21 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
23 **June 18, 1934 (48 Stat. 984).**
