4	WHEREAS, the United States Environmental Protection Agency, Region IX, has approved		
5	this request for an extension; and		
6	WHEREAS, the current GAP Program has sufficient funds of \$29,499.66 to carry over till		
7	September 30, 1999; and		
8	WHEREAS, on August 03, 1999, Resolution No. 98-296, entitled "Acceptance of Grant Award		
9	No. GA989075-01-0 for the FY99 Indian Environmental General Assistance		
10	Program," was adopted; and		
11	WHEREAS, the program period authorized in this Resolution is August 01, 1998 - July 31,		
12	1999; and		
13	WHEREAS, Resolution No. 98-286 must be amended to make the extension effective.		
14	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby		
15	authorizes the extension of the current GAP workplan period to 09/30/99.		
16	BE IT FURTHER RESOLVED by the Tohono O'odham Nation Legislative Council that the		
17	Tohono O'odham Nation's Officials, to wit: the Chairman, Vice Chairman and		
18	any designated official are hereby authorized to negotiate and execute the		
19	grant, provided however, that any amendments affecting funding or funding		
20	levels of the grant shall be submitted for further prior approval.		
21	BE IT FURTHER RESOLVED that the GAP program is authorized to expend funds from this		
22	grant until September 30, 1999.

24	<u>SEPTEMBER. 1999</u> at a meeting at which a quorum was present with a vote of <u>2.165.5</u> FOR; <u>-0-</u>

26	Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the		
27	Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant		
28 29	Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
