

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2000 budget for the First Trinational Health Fair in**  
**Sonoyta, Mexico, October 15, 1999)**

**RESOLUTION NO. 99-520**

1 **WHEREAS, representatives from the Executive Office of the Tohono O'odham Nation,**  
2 **Indian Health Services and Health Officials from Mexico have been meeting**  
3 **for the purpose of ascertaining permission and support from the Mexican**  
4 **Government to allow the Nation with the assistance from Indian Health Services**  
5 **(IHS) to conduct a Health Assessment on its members residing in Mexico; and**

6 **WHEREAS, during the July 1999 meeting with Dr. Linares, Secretary of Health for the State**  
7 **of Sonora, and Dr. Canez, Director of Health for the Region of Sonora, Dr.**  
8 **Linares proposed a Trinational Health Fair as a means for the Nation and**  
9 **Mexico to gather health information; and**

10 **WHEREAS, Indian Health Services agreed that a Trinational Health Fair is another way to**  
11 **obtain information on the O'odham in Mexico, also the health fair would allow**  
12 **the Nation and Indian Health Service to conduct the Focus Group Study for the**  
13 **purpose of developing a survey instrument for door to door health assessment;**  
14 **and**

15 **WHEREAS, Indian Health Services (IHS) agreed to provide funds in the amount of twenty**  
16 **thousand dollars (\$22,550) to support/assist the Nation in participating in the**  
17 **Trinational Health Fair, scheduled for October 15, 1999 in Sonoyta, Mexico; and**

18 **WHEREAS, the Human Services did prepare a budget in support of the Nation to participate**  
19 **in the Trinational Health Fair in Sonoyta, Mexico.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council hereby accepts funds in the**  
21 **amount of \$22,550 provided by Indian Health Service to assist the Nation in**  
22 **participating in the Trinational Health Fair, scheduled for October 15, 1999 in**  
23 **Sonoyta, Mexico.**

24 **BE IT FURTHER RESOLVED that the Legislative Council approves the attached budget in the**  
25 **amount of twenty two thousand five hundred fifty dollars (\$22,550) for the**

1 **purpose as identified in the budget.**

2 **BE IT FINALLY RESOLVED that any unexpended funds from the Trinational Health Fair**

3 **budget be available to the Focus Group Study to support additional sessions.**

5 **SEPTEMBER, 1999 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**

7 **Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
8 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
9 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
10 **June 18, 1934 (48 Stat. 984).**


