4 **WHEREAS, the Budget and Finance Committee on September 22, 1999 did review the FY**
5 **1999 Legislative Branch Budget Amendment No. 3 and recommends for**
6 **approval.**
7 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
8 **approves the FY 1999 Legislative Branch Budget Amendment No. 3.**

9 **The foregoing Resolution was passed by the Tohono O'odham Council on the 23RD day of**
10 **SEPTEMBER, 1999 at a meeting at which a quorum was present with a vote of 1,792.8 FOR;**
11 **372.7 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the**
12 **Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation,**
13 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
14 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
15 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


