

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization to Continue FY 2000 Funding for Arizona Long Term Care
Services Account 01-1416, October 01, 1999 - March 31, 2000)**

RESOLUTION NO. 99-522

1 **WHEREAS, the Tohono O'odham Nation has entered into an Intergovernmental Agreement**
2 **with the State of Arizona to provide ALTCS Case Management services to eligible**
3 **enrolled members; and**

4 **WHEREAS, the Tohono O'odham Nation has been providing ALTCS Case Management**
5 **services since June 1996 and has been receiving reimbursement from the State**
6 **of Arizona for these services; and**

7 **WHEREAS, the ALTCS budget - Account #01-1416 was approved for a six (6) month period**
8 **(October 01, 1999 through March 31, 2000) in the amount of \$75,060.03; and**

9 **WHEREAS, there are sufficient funds for ALTCS revenues to cover salaries and fringe for the**
10 **next six (6) month period (October 01, 1999 - March 31, 2000) in the amount of**
11 **\$75,060.03.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 13 **1. It hereby approves the FY 2000 ALTCS budget from October 01, 1999 to March**
14 **31, 2000.**
- 15 **2. The Tohono O'odham Nation's officials to wit: the Chairman and Vice**
16 **Chairman and any designated official are hereby authorized to negotiate**
17 **and execute the grant, provided however, that any amendment affecting the**
18 **funding or funding levels of this contract shall be submitted for further**
19 **prior approval by this Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Council on the 23RD day of**
22 **SEPTEMBER, 1999 at a meeting at which a quorum was present with a vote of 2,101.45 FOR;**
23 **-0- AGAINST; 64.05 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the**
24 **Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation,**
25 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
26 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
27 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
