5	year operations pending the review and approval of its FY 99/00 budget by the							
6	TOLC; and							
7	WHEREAS, the District has sufficient funds in its treasury to cover all expenditures during							
8	this interim period.							
9	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves							
10	the San Xavier District to continue to expend funds for its regular operation in							
11	the amount of three million fifty five thousand seven hundred and seventy four							
12	cents (\$3,055,770.74) at the FY 98-99 level until its FY99/00 budget has been							
13	reviewed and sanctioned by the Tohono O'odham Legislative Council.

15 16	<u>SEPTEMBER, 1999</u> at a meeting at which a quorum was present with a vote of <u>2,165.5</u> FOR; <u>-0-</u> AGAINST; <u>-0-</u> NOT VOTING; and <u>[01]</u> ABSENT, pursuant to the powers vested in the Council by							
17	Section 1(d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted							
18	by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy							
19	Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of							
20	the Act of June 18, 1934 (48 Stat. 984).
