

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Revenue Projections and Adopting Executive Branch Base Budget
Plan for Fiscal Year 2000)**

RESOLUTION NO. 99-525

1 **WHEREAS, the base budgets from the three branches of the Tohono O'odham Nation as**
2 **presented to the Budget and Finance Committee exceeded the projected**
3 **revenues for fiscal year 2000 resulting in a projected deficit of \$8.7 million; and**

4 **WHEREAS, to reduce the deficit requires either a \$8.7 million reduction in necessary**
5 **programs, services and staffing, or a use of other funding sources; and**

6 **WHEREAS, it is in the best interest of the Nation to use other funding sources; and**

7 **WHEREAS, the Chairman of the Nation did present a plan for the fiscal year 2000 base**
8 **budget that addresses the projected deficit.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council adopts**
10 **the Chairman's plan for the fiscal year 2000 budget as attached and**
11 **incorporated by this reference; and**

12 **BE IT FURTHER RESOLVED that the projected revenues for fiscal year 2000 be hereby**
13 **increased to \$37,533,000 by adding \$4.2 million in accumulated gaming**
14 **revenues from August and September of fiscal year 1999.**

15 **BE IT FURTHER RESOLVED that \$7 million in unspent funds from fiscal year 1999 be applied**
16 **to the budget for fiscal year 2000.**

17 **BE IT FURTHER RESOLVED that the Executive Branch of the Tohono O'odham Nation in**
18 **conjunction with the Judicial and Legislative Branches, together undertake a**
19 **study to be completed within six months that identifies methods for addressing**
20 **and preventing any potential, future shortfalls in funding for government**
21 **operations.**

23 **The foregoing Resolution was passed by the Tohono O'odham Council on the 23RD, day of**
24 **SEPTEMBER, 1999 at a meeting at which a quorum was present with a vote of 1,120.45 FOR;**
25 **1,045.05 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the**
26 **Council by Section 1(d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham**
27 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the**
28 **Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant**
29 **to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


