

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 2000 Budget for the Tohono O'odham Judicial Branch and  
Appropriating Funds in the amount of \$5,036,507.00)**

**RESOLUTION NO. 99-526**

1 **WHEREAS, the 1999 fiscal year ends at midnight, September 30, 1999 and all spending**  
2 **authority granted under the 1999 budgets end at that time; and**

3 **WHEREAS, the continued operation of the Judicial Branch of the Tohono O'odham Nation**  
4 **requires adoption of an operating budget, the grant of spending authority and**  
5 **the appropriation of funds for FY 2000; and**

6 **WHEREAS, the Judicial Branch hereby requests \$120,001.00 to supplement the programs**  
7 **budget to meet the costs of increased salaries for Market Adjustment and**  
8 **Longevity. This total of \$120,001.00 is added to FY 2000 Salary which increases**  
9 **to a grand total of \$4,456,711.00; and**

10 **WHEREAS, the Judicial Branch of the Nation has prepared and presented a budget that**  
11 **reflects the needs of the Branch, said budget is attached hereto and**  
12 **incorporated by reference; and**

13 **WHEREAS, the Judicial and the Budget and Finance Committees of the Legislative Council**  
14 **of the Tohono O'odham Nation have reviewed this budget and recommends its**  
15 **approval and adoption.**

16 **NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the Tohono O'odham**  
17 **Nation that it approves the FY 2000 budget submitted by the Judicial Branch.**

18 **BE IT FURTHER RESOLVED that funds in the amount of \$4,916,506.00 and per the FY 2000**  
19 **Budget Instructions regarding employees' Market and Longevity Adjustments,**  
20 **the total of \$120,001.00 are appropriated and authorized to be expended from**  
21 **sources of funding approved by this Council for support of the FY 2000 budgets**  
22 **of the Tohono O'odham Nation.**

23 **The foregoing Resolution was passed by the Tohono O'odham Council on the 23RD. day of**  
24 **SEPTEMBER, 1999 at a meeting at which a quorum was present with a vote of 1,199.5 FOR;**  
25 **593.3 AGAINST; -0- NOT VOTING; and 372.7 [04] ABSENT, pursuant to the powers vested in the**  
26 **Council by Section 1(d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham**  
27 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the**  
28 **Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant**  
29 **to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
