

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Lobbying Contract between the Tohono O'odham Nation and
Ducheneaux, Taylor & Associates)**

RESOLUTION NO. 99-535

1 **WHEREAS, the Tohono O'Odham Nation recognizes the need to obtain legislative and**
2 **administrative advocacy services in regard to programs and services of the**
3 **Federal government of the United States of America; and**

4 **WHEREAS, the firm of Ducheneaux, Taylor & Associates has continued to provide adequate**
5 **services in Fiscal Year 1999 including; to advise the Nation regarding Federal**
6 **initiatives; to act as liaison with the Federal Executive and Legislative Branches;**
7 **to arrange meetings with Federal Officials; to provide specific reports on**
8 **services provided directly to the Nation; and**

9 **WHEREAS, funds in the amount of \$60,000.00 plus \$10,000.00 have been appropriated in**
10 **anticipated expenses by the Legislative Council of the Tohono O'odham Nation**
11 **for the purpose of obtaining these services in Fiscal Year 2000.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the**
13 **Tohono O'odham Nation's Officials to wit; the Chairman or any designated**
14 **official area hereby authorized to negotiate and execute the contract provided**
15 **in the amount of \$60,000.00 plus \$10,000.00 in anticipated expenses, and that**
16 **any amendments affecting the funding levels of the contract shall be submitted**
17 **for further prior approval by this Council.**

18 **BE IT FURTHER RESOLVED that the contract period will be from October 01, 1999 through**
19 **September 30, 2000.**

21 **The foregoing Resolution was passed by the Tohono O'odham Council on the 29TH, day of**
22 **SEPTEMBER, 1999 at a meeting at which a quorum was present with a vote of 1,442.25 FOR;**
23 **-0- AGAINST; 64.05 NOT VOTING; and 659.2 [07] ABSENT, pursuant to the powers vested in the**
24 **Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,**
25 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
26 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
27 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
