

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Legislative Branch Request for Carry-Over of FY 99 Renovation Balance to
FY 2000 Budget)**

RESOLUTION NO. 99-541

1 **WHEREAS, the Tohono O'Odham Legislative Council approved the FY 99 Legislative Branch**
2 **budget by Resolution No. 98-397, authorizing appropriated funds for**
3 **expenditures.**

4 **WHEREAS, the on-going contract between Modular Solutions and the Tohono O'Odham**
5 **Nation includes the construction of a porch/awning to the facing of the**
6 **Legislative Modular to avoid any potential weather damage to the entry.**

7 **WHEREAS, construction of the porch/awning has delayed the time scheduled for**
8 **completion of the project; and**

9 **WHEREAS, the Legislative Branch foresees to complete the project beginning of fiscal year**
10 **2000, completion of the project will require re-authorization for use of FY 1999**
11 **Appropriated Funds identified within the Modular Solutions Contract; and**

12 **WHEREAS, funds in the amount of \$24,800 have been obligated to the Modular Solutions**
13 **Contract which they were intended for per Amendment No. 2 to the Contract**
14 **between Modular Solutions and the Tohono O'Odham Nation; and**


15 **WHEREAS, any remaining balance exist after the completion of the project will be reverted**
16 **to the Nation's General Funds.**

17 **NOW, THEREFORE, BE IT RESOLVED, by the Tohono O'Odham Legislative Council that it**
18 **hereby approves the attached carry-over amount of \$24,800 per the Legislative**
19 **Branch Request for Carry-over of FY 99 Renovation Balance to FY 2000 Budget.**

21 **The foregoing Resolution was passed by the Tohono O'odham Council on the 30TH day of**
22 **SEPTEMBER, 1999 at a meeting at which a quorum was present with a vote of 1,586.65 FOR;**
23 **436.75 AGAINST; 143.1 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the**
24 **Council by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation,**
25 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
26 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
27 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


