

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Professional Services Contract Between Lucent Technologies  
and the Tohono O'Odham Nation and Approving Addendum No. 4)**

**RESOLUTION NO. 99-542**

1 **WHEREAS, the Tohono O'odham Legislative Council is satisfied with the performance of**  
2 **Lucent Technologies, Inc., and, therefore, wishes to continue a contractual**  
3 **relationship with Lucent Technologies through Fiscal Year 2000; and**

4 **WHEREAS, the Tohono O'Odham Nation has present and anticipated equipment and**  
5 **general services needs during the balance of Fiscal Year 2000.**

6 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council approves**  
7 **Addendum No. 4 between Lucent Technologies and the Tohono O'Odham**  
8 **Nation.**

9 **BE IT FURTHER RESOLVED that the Legislative Council authorizes the Chairman of the**  
10 **Tohono O'Odham Nation and the Chairman of the Legislative Council to sign the**  
11 **Addendum.**

12 **The foregoing Resolution was passed by the Tohono O'odham Council on the 30TH, day of**  
13 **SEPTEMBER, 1999 at a meeting at which a quorum was present with a vote of 1,124.25 FOR;**  
14 **80.0 AGAINST; 961.25 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the**  
15 **Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,**  
16 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**  
17 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**  
18 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
