

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Continuing Authorization for the O'odham Charitable Office Administrative
Cost and Grant Reserve Budgets)**

RESOLUTION NO. 99-543

1 **WHEREAS, the Executive Branch has prepared the O'odham Charitable Office**
2 **Administrative Cost and Grant Reserve Budget for fiscal year 2000 in the amount**
3 **of \$212,784.85 for administrative costs and \$800,000 for a grant reserve fund,**
4 **totaling \$1,012,784.85; and**

5 **WHEREAS, the Fiscal Year 2000 Administrative and Grant Reserve Budget for the O'odham**
6 **Charitable Office was presented to the Tohono O'odham Legislative Council on**
7 **the 23rd and 29th of September, 1999; and**

8 **WHEREAS, the Tohono O'odham Legislative Council requested the Vice-Chairman of the**
9 **Nation and the Manager of the O'odham Charitable Office provide information**
10 **regarding the implementation of the program prior to an authorization and**
11 **appropriation of a fiscal year 2000 budget; and**

12 **WHEREAS, the Tohono O'odham Legislative Council recommended that a temporary**
13 **authorization be granted for the O'odham Charitable Administrative Cost and**
14 **Grant Reserve Budget to continue operations for a period not to exceed 30 days**
15 **beginning October 01, 1999 pending final adoption of the budgets.**

16 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the**
17 **Executive Branch is hereby authorized to continue operations of the O'odham**
18 **Charitable Office for a period of 30 days beginning October 01, 1999 pending**
19 **final adoption of the budgets.**

21 **The foregoing Resolution was passed by the Tohono O'odham Council on the 30TH day of**
22 **SEPTEMBER, 1999 at a meeting at which a quorum was present with a vote of 1,621.0 FOR;**
23 **171.8 AGAINST; 372.7 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the**
24 **Council by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation,**
25 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
26 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
27 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
