
1    **WHEREAS, the Sells District Treasurer presented the Sells District FY 2000 Budget to the**  
2                               **Tohono O'odham Legislative Council for review and approval; and**  
3    **WHEREAS, the FY 2000 Budget covers the cost for the district's administration in the**  
4                               **amount of \$485,384.05; and**  
5    **WHEREAS, a six (6) month budget to cover costs of employee salaries for the Sells District**  
6                               **Restaurant, Convenience Store and Gas Station in the amount of \$219,733.50**  
7                               **is also included for a total of \$705,117.55.**  
8    **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**  
9                               **the Sells District FY 2000 Budget in the amount of \$705,117.55.**  
10   **BE IT FURTHER RESOLVED that Sells District will submit the next six month budget for the**  
11                              **restaurant, convenience store and gas station at the February 2000 General**  
12                              **Session of the Tohono O'odham Legislative Council for approval.**

13   **The foregoing Resolution was passed by the Tohono O'odham Council on the 30<sup>TH</sup> day of**  
14   **SEPTEMBER, 1999 at a meeting at which a quorum was present with a vote of 2,165,5 FOR;**  
15   **-0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the**  
16   **Council by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham**  
17   **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the**  
18   **Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant**  
19   **to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


