2	Start Center and Day Care Centers for its young members and providing for
3	their welfare through various programs and services designed to meet their
4	special needs; and
5	WHEREAS, the Department of Health and Human Services, Administration for Children
6	and Families has awarded the Tohono O'odham Nation a total of \$694,412.00, to
7	implement a Child Care and Development Fund Program; and
8	WHEREAS, the Tohono O'odham Legislative Council is desirous to continue to provide
9	Child Care Services to its young tribal members; and
10	WHEREAS, the Child Care & Development Fund Program of the Tohono O'odham Nation
11	has submitted for review and approval the proposed Grant Year 1999 Funds.
12	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does
13	hereby approve the Child Care and Development Fund FY 2000 Budget for:
14	Grant Year 1999 - Mandatory Funds in the amount of \$549,412.00; and
15	Grant Year 1999 - Discretionary Funds in the amount of \$145,000.00
16	BE IT FURTHER RESOLVED that the duration of this budget would be from October 01, 1999
17	to September 30, 2000.
18	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono
19	O'odham Nation's Officials to wit: the Chairman and any designated officials are
20	hereby authorized to negotiate and execute the grant.
21	The foregoing Resolution was passed by the Tohono O'odham Council on the <u>30TH</u> , day of
22	SEPTEMBER. 1999 at a meeting at which a quorum was present with a vote of <u>2,165.5</u> FOR;
23	<u>-0-</u> AGAINST; <u>-0-</u> NOT VOTING; and <u>[05]</u> ABSENT, pursuant to the powers vested in the Council
24	by Section 1 <u>(f)</u> of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by
25	the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy
26	Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
