

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(To Appoint Mary Ann Antone As Alternate Delegate to National Congress  
of American Indians Convention)**

**RESOLUTION NO. 99-557**

1 **WHEREAS, on September 17, 1999 the Tohono O'odham Legislative approved Resolution**  
2 **99-512 Authorizing the Nation's Delegates to the 56<sup>th</sup> Annual National**  
3 **Congress of American Indians Convention; and**

4 **WHEREAS, Resolution 99-512 authorized the Chairman Edward D. Manuel as the Tohono**  
5 **O'odham Nation voting Delegate and Legislative Council Vice Chairman**  
6 **Ambrose Encinas as the alternate voting delegate; and**

7 **WHEREAS, at the September 29, 1999 Special Session, Vice Chairman Ambrose Encinas**  
8 **informed the Legislative Council that he was not attending the 56<sup>th</sup> Annual**  
9 **National Congress Of American Indians Convention and that an alternate**  
10 **should be appointed by the Council.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**  
12 **hereby authorizes Mary Ann Antone as the alternate voting delegate to the 56<sup>th</sup>**  
13 **Annual National Congress of American Indians Convention.**

14 **The foregoing Resolution was passed by the Tohono O'odham Council on the 30<sup>TH</sup> day of**  
15 **SEPTEMBER, 1999 at a meeting at which a quorum was present with a vote of 1,957.4 FOR;**  
16 **-0- AGAINST; 208.1 NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the**  
17 **Council by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham**  
18 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the**  
19 **Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant**  
20 **to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


