

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Base Roll Addition)**

RESOLUTION NO. 99-560

1 **WHEREAS, Section 1(a) of Article II of the Constitution of the Tohono O'odham Nation**
2 **provides that the Tohono O'odham Council can make additions and changes**
3 **to the official census rolls of the Sells and Gila Bend Reservations dated**
4 **January 1, 1937 and of the San Xavier Reservation dated January 1, 1940, subject**
5 **to the approval of the Secretary of the Interior; and**

6 **WHEREAS, the Enrollment Committee has determined that the following named person(s)**
7 **was a member of the Tohono O'odham Nation on the date of the respective**
8 **census rolls but that their name(s) had been inadvertently omitted therefrom,**
9 **and had recommended that their name(s) be added to the rolls; and**

10 **WHEREAS, the Tohono O'odham Council has reviewed the recommendations of the**
11 **Enrollment Committee and approves thereof.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that, subject to the**
13 **approval of the Secretary of the Interior, the name(s) of the following person(s)**
14 **be added to the official census rolls of the Sells, Gila Bend or San Xavier**
15 **Reservation to wit:**

4209 - ND - 99 PASOS - CELAYA, Ramon

17 **BE IT FURTHER RESOLVED that the required approval be secured from the Secretary of**
18 **the Interior before their name(s) be formally added to such rolls.**

19 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the**
20 **11TH. Day of OCTOBER, 1999 at a meeting at which a quorum was present with a vote of**
21 **2.086.45 FOR; -0- AGAINST; 79.05 NOT VOTING; and [03] ABSENT, pursuant to the powers**
22 **vested in the Council by Section 1(a) of Article II and Section 1(h) of Article VI of the**
23 **Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on**
24 **January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
25 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


