

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Appointments of the O'odham Charitable Advisory Board  
to the O'odham Charitable Office)**

**RESOLUTION NO. 99-565**

1 **WHEREAS, a special election was held on June 28, 1997 known as the "O'odham Voice" that**  
2 **provides a charitable organization within the Nation to "Create an 11 member**  
3 **Board (1 member from each District) to establish an O'odham Charitable**  
4 **Organization (OCO) on the reservation"; and**

5 **WHEREAS, on May 07, 1999 the Legislative Council amended Resolution No. 98-374 to**  
6 **appoint the representation of the O'odham Charitable Advisory Board; term of**  
7 **office and remuneration; and**

8 **WHEREAS, Resolution No. 99-236 of the Legislative Council confirmed the O'odham**  
9 **Charitable Advisory Board appointment and terms of service for Pisinemo**  
10 **District, Sif Oldak District, Gu Achi District, Baboquivari District, San Lucy**  
11 **District, San Xavier District, Schuk Toak District, Gu Vo District, and Hickiwan**  
12 **District; and**

13 **WHEREAS, Chukut Kuk District and Sells District were without representation; and**

14 **WHEREAS, Schuk Toak District representative has resigned; and**

15 **WHEREAS, the following were identified by the Vice-Chairman of the Nation together with**  
16 **the Rules Committee as qualified candidates for appointments; and**

17 **WHEREAS, the power of implementation is vested in the Office of the Chairman of the**  
18 **Tohono O'odham Nation by the Nation's Constitution.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council hereby confirms the**  
20 **following appointments and terms of service:**

22	<b>Sells District</b>	<b>Donald Mendez</b>	<b>2 year term</b>

25 **The foregoing Resolution was passed by the Tohono O'odham Council on the 11<sup>TH</sup> of**  
26 **OCTOBER 1999 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
28 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
31 **June 18, 1934 (48 Stat. 984).**
