

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Resolution No. 99-215, "Approving the Supplemental Funds in the  
amount of \$500,000.00 for the Sif Oidak District")**

**RESOLUTION NO. 99-568**

1 **WHEREAS, the Tohono O'odham Legislative Council pursuant to Resolution No. 98-486**  
2 **appropriated supplemental funds for each of the eleven districts in the amount**  
3 **of \$500,000; and**

4 **WHEREAS, each of the eleven (11) districts presented a budget on utilization of the said**  
5 **funds for their own district needs; and**

6 **WHEREAS, the Sif Oidak District Supplemental Funds was approved by Resolution No. 99-**  
7 **215 as presented to this Council; and**

8 **WHEREAS, the Sif Oidak District is requesting an amendment to change the December 31,**  
9 **1999 expiration date to June 30, 2000 to allow the district more time to expend**  
10 **the supplemental funds.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
12 **adopts the amendment to Resolution No. 99-215 to change the December 31,**  
13 **1999 expiration date to June 30, 2000 to allow the Sif Oidak District to utilize the**  
14 **supplemental funds as outlined in the budget adopted by Resolution No. 99-215.**

15 **BE IT FURTHER RESOLVED that this amendment only changes the time frame from**  
16 **December 31, 1999 to June 30, 2000.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>**  
18 **of OCTOBER 1999 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**  
19 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
20 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
21 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**  
22 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**  
23 **the Act of June 18, 1934 (48 Stat. 984).**


