

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of FY 1999 Community Health Services/HIV Prevention and Control  
Services Budget)**

**RESOLUTION NO. 99-570**

1 **WHEREAS, the Tohono O'odham Nation has operated the Human Immunodeficiency Virus**  
2 **(HIV) Prevention and Control Services Program to provide HIV/ STD prevention**  
3 **education to communities and schools; and**

4 **WHEREAS, funding for the prevention education has been provided by the Arizona**  
5 **Department of Health Services for Human Immunodeficiency Virus (HIV)**  
6 **Prevention and Control Services in the amount of \$6,411.96; and**

7 **WHEREAS, the Tohono O'odham Nation does desire to continue to provide HIV/STD**  
8 **prevention education to communities and schools; and**

9 **WHEREAS, a budget in the amount of \$6,411.96 is submitted for review and approval by the**  
10 **Department of Human Services, Division of Community Health Services to**  
11 **utilize funds for prevention education.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 13 **1. It hereby approves the attached budget submitted by the Division of**  
14 **Community Health Services.**
- 15 **2. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice**  
16 **Chairman and any designated Official are hereby authorized to negotiate**  
17 **and execute this contract and to expend funds when received.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>**  
20 **of OCTOBER 1999 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
25 **June 18, 1934 (48 Stat. 984).**


