

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 2000 Budget Modification #1 for Divisions of Community
Health Representative and Community Health Services)

RESOLUTION NO. 99-584

1 **WHEREAS, the Tohono O'odham Nation is presently operating the Community Health**
2 **Representatives and Community Health Services Divisions for FY 2000 under**
3 **P.L. 93-638 Master Health Contract No. 249-96-0001 with the Indian Health**
4 **Services; and**

5 **WHEREAS, annual salaries of thirteen (13) positions under the CHR/CHS contract are to be**
6 **funded by one half (1/2), therefore the savings in the amount of \$197,589.44 is**
7 **available to utilize for operational costs; and**

8 **WHEREAS, a budget modification is submitted for review and approval by the Community**
9 **Health Representative and Community Health Services Divisions to utilize**
10 **savings from the Personnel line items to cover operational costs.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 12 **1. It hereby approves and authorizes expenditures in accordance with the**
13 **attached budget modification #1 submitted by the Community Health**
14 **Representatives and Community Health Services Division.**
- 15 **2. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice**
16 **Chairman and any designated Official are hereby authorized to negotiate**
17 **and execute this contract and to expend funds when received.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH**
19 **of OCTOBER 1999 at a meeting at which a quorum was present with a vote of 1,094.7 FOR;**
20 **770.9 AGAINST; -0- NOT VOTING; and 299.9 [07] ABSENT, pursuant to the powers vested in the**
21 **Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,**
22 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
23 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
24 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
