3		through the United States Department of Housing and Urban Development; and
4	WHEREAS,	the grant requires a budget modification to make the appropriate and
5		necessary adjustments to the grant budget to bring in the \$79,906.00 awarded
6		for inflation and to increase the line item for Reserve for Contingencies to
7		accommodate \$79,906.00; and
8	WHEREAS,	this budget modification has been reviewed and approved by the following
9		entities and committees of the Tohono O'odham Legislative Council: Grants and
10		Contracts in Accounting, the Executive Committee, the Commerce Committee
11		and the Budget and Finance Committee; and
12	WHEREAS,	this budget modification is as follows: Bringing into the Nation and adding
13		\$79,906.00.00 in awarded inflation funds to the Reserve for Contingencies line
14		item to accommodate a budget adjustment to include funds to address Inflation
15		as provided by HUD.
16	NOW, THE	REFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council
17		hereby approves of the proposed budget modification #2 to the 1997 ICDBG
18		Grant in order to accommodate a change in the budget required to use inflation
