

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with California Indian Legal Services)**

RESOLUTION NO. 99-590

1 **WHEREAS, pursuant to Legislative Council Resolutions 98-464 and 99-448, the Nation**
2 **entered into an Attorney Contract, and Amendment No. 1 thereto, with**
3 **California Indian Legal Services (the "Attorneys") for the purpose of providing**
4 **legal representation to protect the Nation's interests under the Indian Child**
5 **Welfare Act in connection with legal proceedings in the State of California; and**

6 **WHEREAS, the Attorney Contract expired on September 30, 1999; and**

7 **WHEREAS, continued representation is necessary to protect the Nation's interests in these**
8 **proceedings; and**

9 **WHEREAS, the Attorney General has recommended an extension of the Attorney Contract**
10 **for fiscal year 2000 in the amount of \$19,000; and**

11 **WHEREAS, the operating budget for the Office of Attorney General for fiscal year 2000 has**
12 **sufficient funds for a Contract in such amount; and**

13 **WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative**
14 **Council of an Attorney Contract with the Attorneys on such terms.**


15 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 16 **1. The Tohono O'odham Legislative Council hereby approves an Attorney**
17 **Contract with California Indian Legal Services in the amount of \$19,000 for**
18 **the fiscal year ending September 30, 2000 and in the form attached hereto.**
- 19 **2. Funding for the Attorney Contract shall be provided under the fiscal year**
20 **2000 operating budget for the Office of Attorney General.**
- 21 **3. The Chairman of the Nation is authorized and directed to execute the**
22 **Attorney Contract.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the**
24 **15TH day of OCTOBER, 1999 at a meeting at which a quorum was present with a vote of 1,707.2**
25 **FOR; -0- AGAINST; -0- NOT VOTING; and 458.3 [08] ABSENT, pursuant to the powers vested in**
26 **the Council by Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation,**
27 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
28 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
29 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




