

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with Law Firm of Quigley, Tang & Whitehill)**

RESOLUTION NO. 99-593

1 **WHEREAS, by Resolution 98-469 the Tohono O'odham Legislative Council approved an**
2 **Attorney Contract with the law firm of Quigley, Tang & Whitehill (the**
3 **"Attorneys") to provide legal representation with respect to certain bankruptcy**
4 **proceedings affecting the trust status of the San Lucy Farm and litigation and**
5 **negotiations related to the Central Arizona Project (CAP); and**

6 **WHEREAS, the Attorney Contract expired on September 30, 1999; and**

7 **WHEREAS, the CAP litigation is pending and certain issues regarding the trust status of the**
8 **San Lucy Farm are unresolved; and**

9 **WHEREAS, continued representation regarding ongoing matters is required to protect the**
10 **Nation's interests; and**

11 **WHEREAS, the Attorney General has recommended an extension of the Attorney Contract**
12 **for fiscal year 2000 in the amount of \$40,000; and**

13 **WHEREAS, the operating budget of the Office of Attorney General for fiscal year 2000**
14 **includes sufficient funding for the Contract; and**

15 **WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative**
16 **Council of an Attorney Contract with the Attorneys on such terms.**

17 **NOW, THEREFORE, BE IT RESOLVED THAT:**

18 **1. The Tohono O'odham Legislative Council hereby approves an Attorney**
19 **Contract with the law firm of Quigley, Tang & Whitehill in the amount of**
20 **\$40,000 for the fiscal year ending September 30, 2000 and in the form**
21 **attached hereto.**

22 **2. Funding for the Attorney Contract shall be provided under the operating**
23 **budget of the Office of Attorney General for fiscal year 2000.**

24 **3. The Chairman of the Nation is authorized and directed to execute the**
25 **Attorney Contract.**
