10		Nation's interests; and
11	WHEREAS,	the Attorney General has recommended an extension of the Attorney Contract
12		for fiscal year 2000 in the amount of \$40,000; and
13	WHEREAS,	the operating budget of the Office of Attorney General for fiscal year 2000
14		includes sufficient funding for the Contract; and
15	WHEREAS,	the Domestic Affairs Committee recommends approval by the Legislative
16		Council of an Attorney Contract with the Attorneys on such terms.
17	NOW, THER	REFORE, BE IT RESOLVED THAT:
18		1. The Tohono O'odham Legislative Council hereby approves an Attorney
19		Contract with the law firm of Quigley, Tang & Whitehill in the amount of
20		\$40,000 for the fiscal year ending September 30, 2000 and in the form
21		attached hereto.
22		2. Funding for the Attorney Contract shall be provided under the operating
23		budget of the Office of Attorney General for fiscal year 2000.
24		3. The Chairman of the Nation is authorized and directed to execute the
25		Attorney Contract.
