

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with Law Firm of Rothstein, Donatelli,
Hughes, Dahlstrom, Cron & Schoenburg)**

RESOLUTION NO. 99-594

- 1 **WHEREAS, by Resolution 98-466 the Tohono O'odham Legislative Council approved an**
2 **Attorney Contract with the law firm of Rothstein, Donatelli, Hughes,**
3 **Dahlstrom, Cron & Schoenburg (the "Attorneys") to provide legal**
4 **representation with respect to certain of the Nation's gaming matters; and**
5 **WHEREAS, the Attorney Contract expired on September 30, 1999; and**
6 **WHEREAS, continued representation regarding gaming matters is required to protect the**
7 **Nation's interests; and**
8 **WHEREAS, the Attorney General has recommended an extension of the Attorney Contract**
9 **for fiscal year 2000 in the amount of \$5,000; and**
10 **WHEREAS, the operating budget of the Office of Attorney General for fiscal year 2000**
11 **includes sufficient funding for the Contract; and**
12 **WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative**
13 **Council of an Attorney Contract with the Attorneys on such terms.**

14 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 15 **1. The Tohono O'odham Legislative Council hereby approves an Attorney**
16 **Contract with the law firm of Rothstein, Donatelli, Hughes, Dahlstrom,**
17 **Cron & Schoenburg, in the amount of \$5,000 for the fiscal year ending**
18 **September 30, 2000 and in the form attached hereto.**
19 **2. Funding for the Attorney Contract shall be provided under the operating**
20 **budget of the Office of Attorney General for fiscal year 2000.**
21 **3. The Chairman of the Nation is authorized and directed to execute the**
22 **Attorney Contract.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the**
24 **15TH, day of OCTOBER, 1999 at a meeting at which a quorum was present with a vote of 1,707.2**
25 **FOR; -0- AGAINST; -0- NOT VOTING; and 458.3 [09] ABSENT, pursuant to the powers vested in**
26 **the Council by Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation,**


