9		for fiscal year 2000 in the amount of \$5,000; and			
10	WHEREAS,	the operating budget of the Office of Attorney General for fiscal year 2000			
11		includes sufficient funding for the Contract; and			
12	WHEREAS,	the Domestic Affairs Committee recommends approval by the Legislative			
13		Council of an Attorney Contract with the Attorneys on such terms.			
14	NOW, THEREFORE, BE IT RESOLVED THAT:				
15		1. The Tohono O'odham Legislative Council hereby approves an Attorney			
16		Contract with the law firm of Rothstein, Donatelli, Hughes, Dahlstrom,			
17		Cron & Schoenburg, in the amount of \$5,000 for the fiscal year ending			
18		September 30, 2000 and in the form attached hereto.			
19		2. Funding for the Attorney Contract shall be provided under the operating			
20		budget of the Office of Attorney General for fiscal year 2000.			
21		3. The Chairman of the Nation is authorized and directed to execute the			
22		Attorney Contract.
