(Override of Vetoed Resolution No. 99-577, "Granting a Limited Waiver of Sovereign Immunity for Willard R. Manuel")

FAILED RESOLUTION NO. <u>99-600</u>

1	WHEREAS, during the October 13, 1999 General Session of the Tohono O'odham Legislative
2	Council, the Council did pass Resolution No. 99-577; and
3	WHEREAS, upon presentation of Resolution No. 99-577 to the Chairman of the Tohono
4	O'odham Nation, he did disapprove thereof and returned it to the Council with
5	his objections in accordance with the provisions of Article VII, Section 5 of the
6	Constitution of the Tohono O'odham Nation; and
7	WHEREAS, during the November 15, 1999 Legislative Session, the Chairman of the Nation
8	presented to the Legislative Council his justifications in vetoing Resolution
9	99-577 (a copy of which is attached hereto); and
10	WHEREAS, the Legislative Council has reviewed the Chairman's objections and after
11	consideration, again voted to pass Resolution No. 99-577.
12	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does
13	hereby override the Chairman's veto by a vote of two-thirds of the votes cast.
14 15 16	The foregoing Resolution was presented to the Tohono O'odham Legislative Council on the <u>15TH.</u> day of <u>NOVEMBER. 1999</u> at a meeting at which a quorum was present, and by a vote of <u>938.55</u> FOR; <u>1.226.95</u> AGAINST; <u>-0-</u> NOT VOTING; and <u>[03]</u> ABSENT, failed to pass because it did not receive a majority of two-thirds (2/3) <u>[1,443.6]</u> of the votes cast as required by Section
17 18	V of Article VII of the Constitution of the Tohono O'Odham Nation.
