

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2000 Attorney Contracts for: David M. Juarez, Lawrence O. Boswell
and David K. Kovalik to serve as Conflict Attorneys)

RESOLUTION NO. 99-603

1 **WHEREAS, there are no other attorneys to handle conflicts which the Nation's Advocate**
2 **Program is not ethically allowed to handle in the increasing needs of tribal**
3 **members for legal representation in civil and criminal matters; and**

4 **WHEREAS, the Advocate Program wishes to retain David M. Juarez, Lawrence O. Boswell and**
5 **David K. Kovalik to be appointed to represent clients with conflicts of interest**
6 **who can not be represented by the Nation's Advocate Program; and**

7 **WHEREAS, the Advocate Program has presented a contract for David M. Juarez, Lawrence O.**
8 **Boswell and David K. Kovalik which confirms and ratifies the terms and**
9 **conditions related to their services, a copy of which is attached; and**

10 **WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative**
11 **Council of an Attorney Contract with David M. Juarez, Lawrence O. Boswell and**
12 **David K. Kovalik on such terms.**

13 **NOW, THEREFORE, BE IT RESOLVED THAT:**

14 **1. The Tohono O'odham Legislative Council ratifies and approves the Conflict**
15 **Attorney Contracts for David M. Juarez, Lawrence O. Boswell and David K.**
16 **Kovalik in the forms attached hereto, for the period of October 1, 1999**
17 **through September 30, 2000 in the amount not to exceed \$27,000.00 per**
18 **contract or \$81,000.00 total.**

19 **2. Funding for the Conflict Attorney Contracts for David M. Juarez, Lawrence O.**
20 **Boswell and David K. Kovalik shall be provided under the operating budget**
21 **of the Advocate Program for Fiscal Year 2000.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH,**
23 **day of NOVEMBER, 1999 at a meeting at which a quorum was present with a vote of 2,165.5**
24 **FOR; -0- AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the**
25 **Council by Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation,**
26 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
27 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
28 **16 of the Act of June 18, 1934 (48 Stat. 984).**


