11	budget amount of \$40,000.00.

13	of agreement shall commence on October 01, 1999 through September 30, 2000.

15	O'odham Nation's officials, to wit: the Chairman, Vice Chairman and any
16	designated official are hereby authorized to negotiate and execute agreement,
17	provided however, that any amendments affecting the funding levels of the
18	agreement shall be submitted for further prior approval by this Council.
