

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Individuals with Disabilities Education Act (IDEA) Modification #1, Part B FY 1999)**

RESOLUTION NO. 99-616

1 **WHEREAS, the Tohono O'odham Nation has entered into a Master Contract with the**
2 **Secretary of Interior for the purpose of performing certain services, functions,**
3 **programs and/or activities which are funded throughout the Bureau of Indian**
4 **Affairs for the benefit of Indians; and**

5 **WHEREAS, the one time increase in funding by 1998; and**

6 **WHEREAS, the Tohono O'odham Nation hereby exercises her right to prepare a budget**
7 **modification to include one time increase in funding.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
9 **finds that it is in the best interest of the Nation to continue to contract the**
10 **activities, functions, services and/or program identified in the Annual funding**
11 **Agreement for Fiscal Year 2000.**

12 **1. The Chairman of the Tohono O'odham Nation is authorized to negotiate**
13 **and execute the Annual funding Agreement between the Tohono O'odham**
14 **Nation and the Secretary of the Interior for all services, function, activities**
15 **and/or programs as described in the Master Contract at Article 1,**
16 **subsection 2, Purpose, and the Annual funding Agreement for the 2000**
17 **fiscal year.**

18 **2. In the event that Congress does not appropriate any and/or sufficient funds**
19 **commonly known as "Contract Support Funds: for those contracted**
20 **services, functions, activities and/or programs contained in the Annual**
21 **Funding Agreement which would otherwise be eligible for such Contract**
22 **Support Funds then:**

23 **a. The Chairman of the Nation shall notify the Secretary of the**
24 **Department of the Interior that the Nation retrocede, effective at**
25 **midnight on September 30, 2000 all programs, services, functions**

and/or activities contained in the Annual Funding Agreement which are eligible for "Contract Support Funds".

b. The Chairman of the Nation is authorized to pursue any and all legal remedy, which may be available to recoup "Contract Support Funds".

The foregoing Resolution was passed by the Tohono O'odham Council on the 17th day of NOVEMBER, 1999 at a meeting at which a quorum was present with a vote of 2,037.4 FOR; -0- AGAINST; 128.1 NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
