**RESOLUTION NO. 99-617** WHEREAS, the Tohono O'odham Nation has operated a Head Start Program to provide 1 2 educational, health/mental health, and parent involvement services for 3 children three to five years of age; and 4 WHEREAS, the Department of Health and Human Services, Administration for Children 5 and Families provides funds for the continued operation of the Head Start 6 **Program: and** 7 WHEREAS, the Head Start Program has prepared a budget modification which reflects 8 the one time Supplement Grant to provide Training for all Head Start 9 Teachers and to provide quality service to all Pre-school Children. 10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Head Start Fiscal Year 1999 Budget Modification #1 in the 11 12 amount of \$14,177.00 is hereby adopted as presented, and is authorized to be 13 expended accordingly. 14 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono 15 O'odham Nation's Officials to wit: the Chairman, and any designated officials are hereby authorized to negotiate and execute the contract, provided 16 17 however, that any amendments affecting the funding levels of the contract 18 shall be submitted for prior approval by this Council. 19 20 The foregoing Resolution was passed by the Tohono O'odham Council on the  $17^{TH}$ , day of 21 NOVEMBER, 1999 at a meeting at which a quorum was present with a vote of 2.165.5 FOR; 22 -0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, 23 24 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting 25 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to 26 Section 16 of the Act of June 18, 1934 (48 Stat. 984). 27
