

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Enrollment - November)**

**RESOLUTION NO. 99-621**

1 **WHEREAS, the Tohono O'odham Council has reviewed the recommendations of the**  
2 **Enrollment Committee in accordance with Section I of Article VIII of the**  
3 **Enrollment Ordinance, Ordinance No. 05-81, and has made a final**  
4 **determination that the application of the following applicant for membership**  
5 **in the Tohono O'odham Nation be approved:**

7 **SECTION 1(b) ALL CHILDREN BORN TO RESIDENT MEMBERS**

10 **NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the**  
11 **above named applicant is eligible for enrollment as a member of the Tohono**  
12 **O'odham Nation under Section I(a) or (b) of Article II of the Constitution of the**  
13 **Tohono O'odham Nation, and that their application is approved, as herein**  
14 **above indicated.**

15 **BE IT FURTHER RESOLVED that the Chairman and other appropriate**  
16 **officers of the Tohono O'odham Nation reduce this final determination in**  
17 **writing regarding each of the foregoing applications for enrollment in**  
18 **accordance with Section 1(a) of Article XIII of the Enrollment Ordinance; give**  
19 **notice of this Council's determination in accordance with Section 2 of Article**  
20 **XIII of the Enrollment Ordinance; and place the names of each applicant upon**  
21 **the membership roll of the Tohono O'odham Nation in accordance with**  
22 **Sections 2 and 3 of Article X of the Enrollment Ordinance.**

24 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the**  
25 **17TH, Day of NOVEMBER, 1999 at a meeting at which a quorum was present with a vote of**  
26 **2,086.45 FOR; -0- AGAINST; 79.05 NOT VOTING; and [07] ABSENT, pursuant to the powers**  
27 **vested in the Council by Section 1 of Article II and Section 1(h) of Article VI of the**  
28 **Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on**  
29 **January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
30 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.**  
31 **984).**
