

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**

**RESOLUTION NO. 99-624**

1 **WHEREAS, the Tohono O'odham Nation is presently operating the Department of Human**  
2 **Services-Child Welfare-Children's Home Program under P.L. 93-638 Master**  
3 **Contract with the Bureau of Indian Affairs; and**

4 **WHEREAS, such tribal operations have been successful and beneficial for the Tohono**  
5 **O'odham Nation and its members; and**

6 **WHEREAS, a budget modification has been done for the Children's Home budget to include**  
7 **carryover funds of \$143,000.00 from the FY 99 budget.**

8 **NOW, THEREFORE, BE IT RESOLVED:**

- 9           **1. That the Tohono O'odham Legislative Council authorizes the expenditures**  
10           **of these funds according to the attached budget modification for the**  
11           **Children's Home Program in the amount of \$948,257.65.**
- 12           **2. That the Tohono O'odham Nation's Official, to wit: the Chairman, Vice**  
13           **Chairman and any designated Officer are hereby authorized to negotiate and**  
14           **execute the contract.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17<sup>TH</sup>**  
16 **day of NOVEMBER, 1999 at a meeting at which a quorum was present with a vote of 2,165.5**  
17 **FOR; -0- AGAINST; -0- NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the**  
18 **Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,**  
19 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**  
20 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
21 **16 of the Act of June 18, 1934 (48 Stat. 984).**




