**BE IT FURTHER RESOLVED that the Chairman and other appropriate**

1 officers of the Tohono O'odham Nation reduce this final determination in  
2 writing regarding each of the foregoing applications for enrollment in  
3 accordance with Section 1(a) of Article XIII of the Enrollment Ordinance; give  
4 notice of this Council's determination in accordance with Section 2 of Article  
5 XIII of the Enrollment Ordinance; and place the names of each applicant upon  
6 the membership roll of the Tohono O'odham Nation in accordance with  
7 Sections 2 and 3 of Article X of the Enrollment Ordinance.

8 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the  
9 6TH. Day of DECEMBER, 1999 at a meeting at which a quorum was present with a vote of  
10 1,999.6 FOR; -0- AGAINST; -0- NOT VOTING; and 165.9 [07] ABSENT, pursuant to the powers  
11 vested in the Council by Section 1 of Article II and Section 1(h) of Article VI of the  
12 Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on  
13 January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
14 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.  
15 984).
