

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting Certification of Eligible Members and Authorizing the Initial
Expenditure of Funds for Per Capita Payments under the Initiative)**

RESOLUTION NO. 99-635

1 **WHEREAS, on June 28, 1997 the voters of the Tohono O'odham Nation (the "Nation")**
2 **approved Initiative No. IN-01-97 (the "Initiative"); and**

3 **WHEREAS, the Initiative authorized funding from Gaming Revenues for several**
4 **measures, including a one-time per capita distribution of \$2,000 to each**
5 **member of the Nation enrolled on June 28, 1997 (the "Initial Per Capita**
6 **Distribution"); and**

7 **WHEREAS, pursuant to Resolution 97-451, the Legislative Council adopted an Initiative**
8 **Funding and Implementation Plan (the "FIP") which authorized the**
9 **establishment of set-aside accounts for the Initial Per Capita Distribution and**
10 **other Initiative measures, and set certain conditions on the expenditure of**
11 **funds from such accounts; and**

12 **WHEREAS, by Resolution 97-478, the Legislative Council approved the transfer of funds**
13 **from the Desert Diamond Savings Account to certain designated set-aside**
14 **accounts established at Bank of America Arizona, including the sum of \$41.5**
15 **million to set-aside account no. 3030425-1067524 for the Initial Per Capita**
16 **Distribution (the "Per Capita Account"); and**

17 **WHEREAS, three of the conditions to expenditure of the Per Capita Account specified in**
18 **the FIP are (1) approval by the Secretary of the Interior of a per capita**
19 **distribution plan (the "Revenue Allocation Plan") pursuant to the**
20 **requirements of the Indian Gaming Regulatory Act, 25 U.S.C. § 2710 (b) (3); (2)**
21 **acceptance by the Legislative Council of a Certification of Eligible Members**
22 **submitted by the Enrollment Office and based upon receipt of a properly**
23 **completed and filed Certificate of Eligibility Verification for Per Capita**
24 **Payment for each member; and (3) as to each Minor Eligible Member,**
25 **establishment of a restricted account at Bank of America for deposit of such**
26 **member's per capita payment; and**

- 1 **WHEREAS, pursuant to Resolution 97-452, the Legislative Council adopted a Revenue**
2 **Allocation Plan and caused the Plan to be submitted for approval by the**
3 **Phoenix Area Office of the Bureau of Indian Affairs in accordance with**
4 **authority delegated to the Area Office by the Secretary of the Interior; and**
5 **WHEREAS, by letter dated December 18, 1997, the Area Office approved the Revenue**
6 **Allocation Plan with respect to the Initial Per Capita Distribution and**
7 **disapproved the Plan with respect to the Biennial Per Capita Payments; and**
8 **WHEREAS, an agreement with Bank of America has not yet been finalized for the**
9 **establishment of the restricted accounts which is required as a condition to**
10 **disbursement of the Initial Per Capita Distribution to such accounts for Minor**
11 **Eligible Members; and**
12 **WHEREAS, pursuant to Resolution Nos. 97-525, 98-010, 98-037, 98-084, 98-128, 98-192, 98-**
13 **207, 98-278, 98-316, 98-360, 98-431, 98-478, 98-505, 99-006, 99-041, 99-081, 99-**
14 **142, 99-201, 99-312, 99-363, 99-422, 99-478, 99-563 and 99-622 the Legislative**
15 **Council accepted and approved Certifications of Eligible Members for the**
16 **Initial Per Capita Distribution, and disbursements have been made to such**
17 **members; and**
18 **WHEREAS, Resolution No. 99-622 contained a duplication error with respect to listed**
19 **members of the Gu Achi District, and no payments have been made to any**
20 **correctly listed members under Resolution No. 99-622; and**
21 **WHEREAS, the Enrollment Office has filed with the Legislative Council a Certification of**
22 **Eligible Members listing 61 adult members who are eligible for receipt of the**
23 **Initial Per Capita Distribution which includes correct listed members from**
24 **Resolution No. 99-622; and**
25 **WHEREAS, all conditions under the laws of the United States and the Nation have been**
26 **satisfied to permit the disbursement of the Initial Per Capita Distribution to**
27 **the members listed in the Certification of Eligible members.**

1 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 2 **1. Resolution No. 99-622 is rescinded to eliminate the duplication error.**
- 3 **2. The Tohono O'odham Legislative Council hereby accepts and approves**
- 4 **the Certification of Eligible Members, in the form attached hereto.**
- 5 **3. The Legislative Council authorizes (a) the transfer of the sum of**
- 6 **\$122,000.00 from the Per Capita Account to the special checking account**
- 7 **no. 252-350-324 established at Bank of America Arizona (the "Per Capita**
- 8 **Checking Account"); and (b) upon the joint signature of the Chairman and**
- 9 **Vice Chairman of the Nation, issuance of a check on the Per Capita**
- 10 **Checking Account in the amount of (i) \$2,000 to each Eligible Member**
- 11 **residing in the United States and listed in the attached Certification of**
- 12 **Eligible Members and (ii) \$1,400 to each Eligible Member residing outside**
- 13 **the United States and listed in the attached Certification, with the balance**
- 14 **of \$600 withheld and remitted to the Internal Revenue Service pursuant**
- 15 **to the requirements of federal law.**
- 16 **4. The Chairman of the Nation is authorized to execute such other**
- 17 **documents as may be necessary to implement this Resolution.**

18 **The foregoing Resolution was passed by the Tohono O'odham Council on the 6TH of**

19 **DECEMBER 1999 at a meeting at which a quorum was present with a vote of 1,919.6 FOR; 80.0**

20 **AGAINST; -0- NOT VOTING; and 165.9 [07] ABSENT, pursuant to the powers vested in the**

21 **Council by Section 1 (d)(1), (2) & (3) of Article VI of the Constitution of the Tohono O'Odham**

22 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the**

23 **Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant**

24 **to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


