1	WHEREAS, the National Indian Health Board (NIHB) is a non-profit organization
2	representing all federally recognized tribes in the United States in advocating
3	for the improvement of health care delivery; and
4	WHEREAS, the National Indian Health Board members and alternates represent each of the
5	twelve (12) Indian Health Service Areas and are generally elected at large by
6	tribal governmental officials within each Area; and
7	WHEREAS, since 1972 the Tohono O'odham Nation has had a representative and alternate
8	representative to serve on the National Indian Health Board; and
9	WHEREAS, the Tohono O'odham Nation supports and approves the appointment of Muriel
10	J. Segundo to continue to serve as the Tucson Area representative to the National
11	Indian Health Board and that Ruben Howard, from the Pascua Yaqui Tribe serve
12	as alternate representative to the National Indian Health Board.
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does
14	hereby support and approve Muriel J. Segundo as the Tucson Area
15	Representative to the National Indian Health Board and Ruben Howard from the
16	Pascua Yaqui Tribe as the Alternate Representative to the National Indian Health
17	Board.
