4		Garcia Strip Community within the Schuk Toak District, Tohono O'odham
5		Nation; and
6	WHEREAS,	the Tohono O'odham Nation has an invested interest in the field of agriculture
7		for its members; and
8	WHEREAS,	membership in the Southwest Indian Agriculture Association (SWIAA) is open to
9		any Indian organization recognized by its Tribal Government and/or federally
10		recognized tribe with an interest in the management and development of Indian
11		Agriculture resources; and
12	WHEREAS,	the Agriculture Committee recommends that the Tohono O'odham Nation be a
13		member of and have a representative to the Southwest Indian Agriculture
14		Association (SWIAA) to voice the Nation's interests and position on Indian
15		agricultural issues; and
16	WHEREAS,	the Agriculture Committee has discussed and recommends to the Tohono
17		O'odham Legislative Council the appointment of Frances G. Antone as the
18		Tohono O'odham Nation's representative and also hereby appoints Mary Flores
19		as alternate representative to the Southwest Indian Agriculture Association
20		(SWIAA); and
21	WHEREAS,	membership dues for the Tohono O'odham Nation in the amount of two hundred
22		dollars (\$200.00) for calendar year 2000 are due and payable.
23	NOW, THEI	REFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
24		approves the Nation's membership in the Southwest Indian Agriculture
25		Association (SWIAA) and authorizes payment of annual membership dues in the
26		amount of two hundred dollars (\$200.00) for calendar year 2000.
