


**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 2000 Water Resources Study Program Budget Justification)**

RESOLUTION NO. 99-642

1 **WHEREAS, the Tohono O'odham Nation is presently operating the Water Resources Study**
2 **Program under a P.L. 93-638 Contract with the Bureau of Reclamation; and**
3 **WHEREAS, such tribal operations have been successful and beneficial to the Tohono**
4 **O'odham Nation; and**
5 **WHEREAS, the Tohono O'odham Nation as part of the original award asked for a cost of**
6 **\$2,038,080.00 for fiscal year 2000 to the Bureau of Reclamation for the**
7 **continuation of the Water Resources Study Program during the fiscal year 2000;**
8 **and**
9 **WHEREAS, the United States has a statutory obligation pursuant to Section 303 (b) (1) of the**
10 **Southern Arizona Water Rights Settlement Act to provide funds for the Water**
11 **Resource Study Program; and**
12 **WHEREAS, the Water Resource Study Program does submit for review and approval of**
13 **budget justification reflecting the amount of \$1,615,145.00 and the program will**
14 **submit at a later date a budget modification to reflect the full appropriation for**
15 **FY 2000.**
16 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does**
17 **hereby authorize expenditures per attached budget for the implementation of**
18 **the Water Resource Study Program.**
19 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
20 **O'odham Nation's Officials, to wit: the Chairman, Vice Chairman and any**
21 **designated Official are hereby authorized to negotiate and execute the Contract,**
22 **provided however, that any amendments affecting the funding or funding levels**
23 **of the Contract shall be submitted for further prior approval by this Council.**
24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 7TH,**
25 **day of DECEMBER, 1999 at a meeting at which a quorum was present with a vote of 1,839.6**
26 **FOR; 160.0 AGAINST; -0- NOT VOTING; and 165.9 [08] ABSENT, pursuant to the powers vested**
27 **in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,**
28 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
29 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
30 **16 of the Act of June 18, 1934 (48 Stat. 984).**


