

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2000 Budget for the Child Care & Development Fund for
Grant Year 1999 Fund-Discretionary)**

RESOLUTION NO. 99-643

1 **WHEREAS, the Tohono O'odham Nation is presently operating the Early Childhood Head**
2 **Start Center and Day Care Centers for its young members and providing for their**
3 **welfare through various programs and services designed to meet their special**
4 **needs; and**

5 **WHEREAS, the Department of Health and Human Services, Administration for Children and**
6 **Families has awarded to the Tohono O'odham Nation in the amount of**
7 **\$694,412.00, Resolution No. 99-554, Fiscal Year 2000, to implement a Child Care**
8 **and Development Fund Program; and**

9 **WHEREAS, the Child Care & Development Fund Program has picked up part of the salary**
10 **cost of \$30,901.00 for this fiscal year 2000 due to decrease in two of program's**
11 **budgets. The remaining salary cost will be a cost share with other budgets; and**

12 **WHEREAS, the Child Care & Development Fund Program award amount was budgeted at**
13 **\$145,000.00, when it should have been at \$145,438.00. A difference of \$438.00; and**

14 **WHEREAS, the Tohono O'odham Legislative Council is desirous to continue to provide Child**
15 **Care Services to its young tribal members; and**

16 **WHEREAS, the Child Care & Development Fund Program of the Tohono O'odham Nation has**
17 **submitted for review and approval for the proposed Grant Year 1999 Funds.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does**
19 **hereby approve the Child Care & Development Fund FY 2000 Budget for**
20 **\$145,438.00.**

21 **BE IT FURTHER RESOLVED that the duration of this budget would be from October 01, 1999**
22 **to September 30, 2000.**

23 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
24 **O'odham Nation's Officials to wit: the Chairman and any designated officials are**
25 **hereby authorized to negotiate and execute the contract, provided however, that**



1 **any amendments affecting the funding levels of the contract shall be submitted**
2 **for prior approval by this Council.**

8 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
9 **16 of the Act of June 18, 1934 (48 Stat. 984).**
