

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Decrease in Funding for FY 2000 Budget for the Child Care &
Development Fund-Grant Year 2000-Discretionary)**

RESOLUTION NO. 99-645

1 **WHEREAS, the Tohono O'odham Nation is presently operating the Early Childhood Head**
2 **Start Center and Day Care Centers for its young members and providing for their**
3 **welfare through various programs and services designed to meet their special**
4 **needs; and**

5 **WHEREAS, the Department of Health and Human Services, Administration for Children and**
6 **Families has awarded the Tohono O'odham Nation a total of \$773,556.00,**
7 **Resolution No. 99-553, Fiscal Year 2000, to implement a Child Care and**
8 **Development Fund Program; and**

9 **WHEREAS, the funding agency has decreased the award from \$173,447.00 to \$83,408.00, a**
10 **decrease of \$90,039.00; and**

11 **WHEREAS, the Tohono O'odham Legislative Council is desirous to continue to provide Child**
12 **Care Services to its young tribal members; and**

13 **WHEREAS, the Child Care & Development Fund Program of the Tohono O'odham Nation has**
14 **submitted for review and approval the proposed Grant Year 2000 Funds.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does**
16 **hereby approve the Child Care & Development Fund FY 2000 Budget for**
17 **\$83,408.00.**

18 **BE IT FURTHER RESOLVED that the duration of this budget would be from October 01, 1999**
19 **to September 30, 2000.**

20 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
21 **O'odham Nation's Officials to wit: the Chairman and any designated officials are**
22 **hereby authorized to negotiate and execute the grant.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH,**
24 **day of DECEMBER, 1999 at a meeting at which a quorum was present with a vote of 1,999.6**
25 **FOR; -0- AGAINST; -0- NOT VOTING; and 165.9 [08] ABSENT, pursuant to the powers vested in**
26 **the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,**
27 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
28 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
29 **16 of the Act of June 18, 1934 (48 Stat. 984).**




