

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Internal Modification No. 09 for Grant Agreement 6-FG-32-00100)**

RESOLUTION NO. 99-653

1 **WHEREAS, the Tohono O'odham Legislative Council did previously adopt calendar year**
2 **budgets containing projections for administration of the P.L. 93-638 Grant**
3 **Agreements 6-FG-32-00100; and**

4 **WHEREAS, a funding agreement for calendar year 2000 is being executed by the Nation and**
5 **the Bureau of Reclamation; and**

6 **WHEREAS, the Water Projects Office has presented this modification to the appropriate**
7 **committees and the committees wish to bring it before the Legislative Council.**

8 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**
9 **hereby approves Budget Modification No. 09 to the Grant Agreement and**
10 **authorizes expenditures as identified in the modification attached hereto.**

11 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH,**
12 **day of DECEMBER, 1999 at a meeting at which a quorum was present with a vote of 1,877.4**
13 **FOR; 160.0 AGAINST; 128.1 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in**
14 **the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,**
15 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
16 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
17 **16 of the Act of June 18, 1934 (48 Stat. 984).**
